## STOP

Highbanking or any mechanical use to recover gold on GPAA of Northern Nevada, Reno owned or adopted claims is not allowed, this is for California claims we own or adopted. When and if mechanical equipment becomes legal again it will still not be allowed on our adopted claims.

What we risk if we use mechanical equipment to recover gold on any of our claims owned or adopted - Confiscation of our equipment including truck and trailer and a hefty citation from the authority's. Also, we could cause loss of access to the claim by the membership, as on our adopted claims the use of mechanical equipment was not agreed to with the owners. We could also lose our non-profit status.

So, if you are one of the members using such equipment- STOP.

Why you ask- in California it is against the law- and as a non-profit we cannot break the law no matter how in-just we think it is, also our adopted claim owners have not agreed to us using machinery of any kind on the claims.
